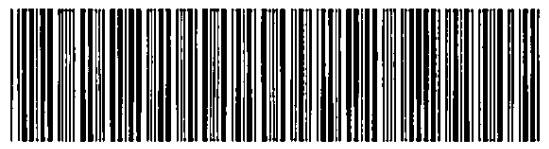

## **ARTICLES OF INCORPORATION**

**OF**

**CHADDAH, INC.**

a Florida Not For Profit Corporation

**THE UNDERSIGNED**, for the purpose of forming a not for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

### **ARTICLE I** **NAME**

The name of this corporation is CHADDAH, INC. The principal place of business is 6231 North W Street, Pensacola, Florida 32505. Mailing address is 6231 North W Street, Pensacola, Florida 32505.

### **ARTICLE II** **DURATION**

The duration of this corporation is perpetual.

### **ARTICLE III** **PURPOSE**

The corporation is a not for profit corporation under Chapter 617, Florida Statutes. The corporation is not formed for pecuniary gain or profit, direct or indirect, to itself or its members, directors or officers. No part of the income or assets of the corporation is distributable to or for the benefit of its directors or officers. The corporation is organized, and shall be operated exclusively for charitable purposes to offer outreach, educational and other related services to human trafficking victims. The corporation is organized to do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activity not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3), of the Internal Revenue Code.

### **ARTICLE IV** **REGISTERED OFFICE AND AGENT**

The street address of the initial registered office, and the mailing address of the registered agent is 2045 Fountain Professional Ct., Suite A, Navarre, Florida, 32566, and the name of its initial registered agent at such address is Kerry Anne Schultz, Esquire.

**ARTICLE V**  
**BOARD OF DIRECTORS**

There shall be a board of directors consisting of at least three individuals. The initial directors are elected by the incorporators. After that, each director shall be elected by majority vote of the board of directors in the manner and at the times set forth in the bylaws. Any director may be removed by the affirmative vote of at least two-thirds of the board of directors. The names of the persons who are to serve as the initial directors are:

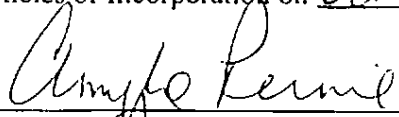
**ARTICLE VIII**

**DISSOLUTION**

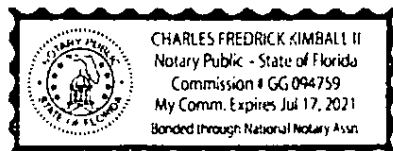

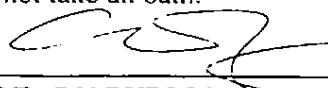

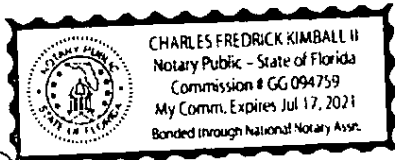
