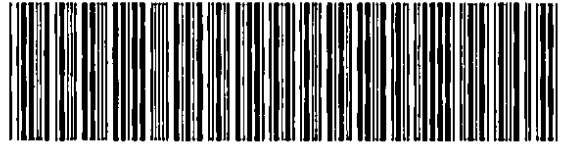

**Article I – Name**

The name of the Corporation shall be Ready Network Relief, Inc.

**Article II – Address of Corporation**

**Article III - Purpose**

The specific purpose for which this Corporation is organized is to provide immediate disaster relief to persons and communities in areas of the United States who become subjected to natural and/or manmade calamities, including, but not limited to, such events as earthquakes, hurricanes, tornadoes, and/or severely acute economic dislocations. During any such disastrous calamity, the Corporation will endeavor to supply persons and communities with such important necessities as clean drinking water, shelter, solar power, medical supplies, tents, sleeping bags, and other critical supplies.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**Article IV – Manner of Election**


