## SECOND ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of ACADEMIC MEDICAL GROUP, INC.

Document Number N20000009600

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, Academic Medical Group, Inc., a Florida not for profit corporation, hereby adopts the following amendment to its Articles of Incorporation:

- 1. <u>Name of Corporation</u>. The name of the Corporation is Academic Medical Group, Inc. (the "Corporation").
- 2. Text of Amendment.
  - A. Article III of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

## "ARTICLE HI Purpose

The Corporation is organized and shall be operated exclusively for charitable, educational and scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code"), and in connection therewith is organized and shall operate exclusively for the benefit of, to support certain functions of, and to carry out certain charitable and educational purposes of Florida Health Sciences Center, Inc. d/b/a Tampa General Hospital, a Florida not for profit corporation, and the University of South Florida Board of Trustees, a public body corporate, for its division known as USF Health, all as provided in Section 509(a)(3) of the Code, including, without limitation, expanding the availability of professional medical services, and promoting public health by various means, including educating and training of medical professionals. Except as limited under Article XI of these articles of incorporation, the Corporation shall have all powers now or hereafter granted by law and, in addition thereto, shall have all powers lawfully necessary or required to carry out its purposes and objects."

- 3. <u>Date of Adoption</u>. The Amendment was adopted on \_\_\_\_\_\_, 2022.
- 4. Manner of Adoption. The Amendment was adopted by the member and the board of directors of the Corporation by written consent in lieu of a meeting dated May 2, 2022. The number of votes cast in favor of the Amendment was sufficient for approval.
