### ARTICLES OF INCORPORATION

### OF

### ONE WAVE AT A TIME, INC.

These articles of incorporation of a Florida not-for-profit corporation are being adopted pursuant to the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes.

### Article I

The name of the corporation shall be One Wave at a Time, Inc.

# **Article II**

The principal street and mailing address for the corporation is 548 Moultrie Wells Road, St. Augustine, Florida 32086.

# Article III

The corporation is organized exclusively for charitable purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code. This corporation shall be a nonprofit corporation. The specific purpose for which the corporation is organized is to provide and foster positive experiences and access to the joy of surfing to children and families from under resourced communities.

### Article IV

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(3)(c) of the Internal Revenue Code, or any corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

# Article V

The manner in which the directors and officers of the corporation are elected or appointed shall be set forth in the Bylaws of the corporation provided, however, that there must be at least three Directors elected or appointed at all times.
