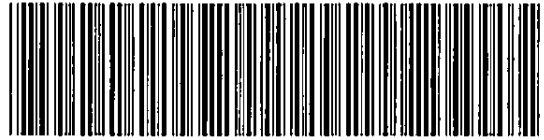

#### Amendments Adopted


**Please amend Article III to read as follows:**
