

ARTICLES OF AMENDMENT



The heading at the top of the first page of the Articles of Incorporation shall be amended to read as follows:

ARTICLES OF INCORPORATION **OF** VISTA VERDE WEST CONDOMINIUM ASSOCIATION, INC.

ARTICLE I, NAME, shall be amended to read as follows: В.

The name of this corporation shall be Vista Verde West Condominium Association, Inc., hereinafter referred to as the "Association".
