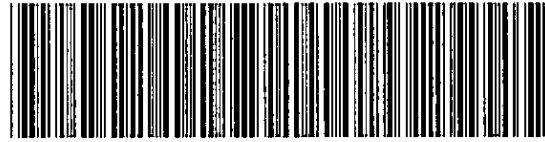



ARTICLE III Purpose

This corporation is organized exclusively for charitable, religious, literary, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code. The Corporation may receive and administer funds for charitable, religious, literary, educational, or scientific purposes, with the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986.

Church is the English rendering of one Greek word *ekklesia*, signifying a "call out assembly." The Church is the Body of Christ. It is God's body on earth and the instrument through which His presence flows. Scripture plainly states that we are not to forsake the assembling together. The reason that **REDEM'S CHURCH OF JESUS CHRIST, INC.** exists is as follows:

1. The object, business and purpose of the corporation is to provide a place for the support public worship, by organizing a church and enhancing all the functions and privileges necessary and nonpolitical services.
2. The corporation shall be devoted to promoting a spirit of religious brotherhood and fellowship on a Interdenominational basis.
3. To train and teach religious education for Christian and public service through the school of biblical studies and seminary, job training, youth Christian School, daycare facility, and a family life center.
4. To be the vessel where God builds upon the Body through the perfecting work of Jesus Christ as we are conformed to His image (2 Corinthians 3:18).
5. To be the vessel where the people of God may assemble, calling upon the name of the Lord, and worship Him in Spirit and truth (Acts 2:1, 2; Hebrews 10:24-25).

6. To be the instrument that God uses to evangelize the world by the "spreading of the Light" so that men may see our good works, glorify God and become members of His Body (John 15:5,8; Acts 1:8).
7. To be the vessel that God uses to strengthen the family by teaching and exemplifying Biblical family values (Deuteronomy 6:6-11).
8. To receive property by gift, devise or bequest subject to the laws relating to the transfer of property by gift or will;
9. To act as Trustee under any trust incidental to the principal objects of the corporation and to receive, hold, administer and expend funds and property subject to such trust;
10. To take, purchase or otherwise acquire; to own, hold, occupy, use; manage, improve, develop and work; to grant, sell, exchange, let, demise and otherwise dispose of real estate, buildings, and improvements and every right, interest, and estate therein without limit as to the amount thereof and wheresoever's the same may be situated; to erect, construct, alter and repair buildings; to assume any and every kind of contract, agreement and obligation by or with any person, firm, corporation, or association, or any Federal, State, or other government for the erection, construction, alteration, repair, renewal, equipment, improvement, development, use, leasing, management or control of any buildings, improvements or structures of any kind wherever the same may be situated;
11. To enter into, make, perform, and carry out contracts of every kind for any lawful purpose without limit as to amount and with any person, firm, association or corporation; to draw, make, accept, endorse, discount, issue, and execute promissory notes, warrants, and other negotiable or transferrable interests;
12. To purchase or otherwise acquire, to own, hold, use, to sell, assign and transfer, exchange or otherwise dispose of, deal in or deal with personal property of every kind and description without limit as to the amount thereof, and affairs and attainment of the exempt purposes of the corporation and to have and exercise all the powers now or hereafter conferred by the laws of the State;

Article IX **Non-profit Nature**

Section 1 - Non-profit Nature

Redem's Church of Jesus Christ, Inc. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of **Redem's Church of Jesus Christ, Inc.** shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Redem's Church of Jesus Christ, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

Section 2 - Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of **Redem's Church of Jesus Christ, Inc.** of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

Section 3 - Dissolution

Upon termination or dissolution of the **Reedem's Church of Jesus Christ, Inc.** any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the **Reedem's Church of Jesus Christ, Inc.** hereunder shall be selected by the discretion of a majority of the managing body of the **Reedem's Church of Jesus Christ, Inc.** and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the **Reedem's Church of Jesus Christ, Inc.** by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

Section 4 - Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.
