The I Am House supports homeless women and their children that have survived domestic abuse or violence. Safety and mental health are at the forefront of our mission. Our programs are designed to be a catalyst that helps families gain a safe space through transitional and emergency housing resources and empower them to overcome anxiety, depression, post-traumatic stress disorder (PTSD), low self-esteem, suicidal ideation or attempts, and substance abuse through our enrichment programs.

We emphasize preparing women to achieve economic freedom and long-term stability so they can break the generational cycles of abuse.

The specific objectives and purpose for which this corporation is organized are exclusively charitable and educational and may consist of the following:

- a. to provide *emergency and transitional housing resources* to women and their children who are homeless as a result of an abusive relationship;
- b. to provide *personal development resources*: spiritual enrichment, counseling, life skills classes, goal setting, and case management after a needs and means assessment on both women and children;
- c. to provide *employment and career resources*: job and interview preparation and soft skills classes, providing access to jobs, skills matching, purpose coaching, mentoring, networking, and business development coaching;
- d. to provide *educational and training resources*: GED and trade classes, tutoring for women and their children;
- e. to provide *health and wellness resources on the following topics*: nutrition, developing better eating habits, disease/illness prevention, healing strategies, and extracurricular activities;
- f. to provide *financial management resources*: financial freedom courses to assist with debt reduction and budget training;
- g. to *fund capital resources*: grants, donations, contributions, scholarships, and sponsorships to families who are a part of our program and other women and their children in the community;
- h. to *promote community-wide interest and concern for the impacts of domestic abuse on women and their children through, but not limited to*: annual awareness events and survivor/victims workshops;
- i. to *sponsor, host, and/or participate* in events and activities that bring awareness to the impacts of domestic abuse/violence and the betterment of women and their children who have survived it;
- j. Subject to the limitations stated in the Articles of Incorporation, this corporation may engage in any other lawful activity for which corporations may be organized under Section 501(c)(3) of the Internal Revenue Code (or its corresponding future provisions).


