

# ARTICLES OF INCORPORATION

OF

#### MADAME SECRETARY:

In compliance with **Chapter 617** of the Florida Statutes (Not for Profit), the Incorporator respectfully submits these Articles of Incorporation as follows:

#### Article I Name:

The name of the corporation shall be:

#### THE HAPPY CAMPER PROJECT, INC.

Inc. is an abbreviation of "Incorporation" which is language that clearly indicates that The Happy Camper Project, Inc. is a corporation instead of a natural person as provided pursuant to Florida Statutes § 617.0401(1)(a) (Corporate Name of Corporations Not for Profits).

### Article II Principal Office:

The Principal street address of the Corporation is:

## Article III: Purposes:

- (a.) The purposes for which The Happy Camper Project, Inc. is formed is any purpose for which corporations may be organized under the Florida Law for Corporations Not for Profit (Chapter 617) including the ownership and leasing of real property and all powers provided pursuant to Florida Statutes § 617.0302 (Corporate Powers).
- (b.) The following language relates to the The Happy Camper, Inc.'s tax exempt status and is not a statement of purposes and powers. Consequently, this language is not intended to and does not expand or alter the corporation's purposes or powers set forth above in Article III(a.)
  - i.) Notwithstanding any other provisions of these articles, The Happy Camper Project, Inc. is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws.
  - ii.) No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporation assets on dissolution of the corporation.
  - iii.) No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code Section 501(h)) or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.
  - iv.) In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses, thereof be distributed to another organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local

- government for public purposes, subject to an order of a Florida Court, if required.
- v.) In any taxable year in which the corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code of 1986, the corporation shall distribute its income for said period at such time and manner as to not subject it to tax under Section 4942 of the Code and the corporation shall not:
  - (a.) engage in any act of self-dealing as defined in Section 4941(d) of the Code;
  - (b.) retain any excess business holdings as defined in Section 4943(c) of the Code;
  - (c.) make any investments in such manner as to subject the corporation to tax under Section 4944 of the Code; or
  - (d.) make any taxable expenditures as defined in Section 4945(d) of the Code or corresponding provisions of any subsequent Federal tax laws.
