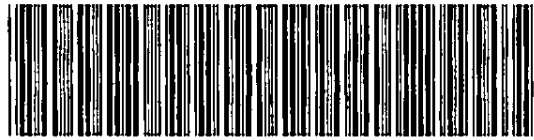

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

ARTICLE III

The specific purpose for which this corporation is organized is:

The organization is organized exclusively for charitable, religious, educational, or scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The organization's purpose is to be a non-profit organization helping youth in the community by addressing different facets of needs: education, scholarships, mental health, learning disabilities, life skills, mentorship, tutoring, etc. by providing resources, athletic programs, counsel and financial assistance through grants and scholarships and working with other youth programs in the community as a support system.

ARTICLE IV

Activities

The activity of the organization includes but is not limited to providing an athletic program for exposure to scholarship programs, reading and math development, career exploration, goal setting/decision making, and life skills classes. The organization utilizing peer-to-peer programs, mentors, tutors and community-based organizations will provide resources to keep youth on a productive track towards adulthood.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in

opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the internal revenue code, or the corresponding section of any future federal tax code.

ARTICLE V

The Board of Directors is elected or appointed based on the term in office, as provided for in the Bylaws of the organization.
