· "STATEMENT OF FACTS"

- I, Jaime Alexander Davidson, is hereby being referred to herein as Jaime A. Davidson. (President, Treasurer, and/or Director), inside of this legal document, and the Statement of Facts are all true and are as follows:
- 1. On or around January 11, 2022, the President met Mr. Laban J. McCormack;
- 2. On or around January 25, 2022, Mr. McCormack who is a music promoter and artist manager became the President's manager, whose artist name is Gringo Man "El Original;"
- 3. On or around February 1st, 2022, the President began working for Mr. McCormack at his company called, "Caribbean Law & Tax Services;"
- 4. Now, the President states that once Mr. McCormack heard Jaime A. Davidson's story on the Panamanian TV Channel, the President's story moved Mr. McCormack, to the point that he (Mr. McCormack), on his own volunteered to assist the President start his non-profit organization named FEHR Foundation (Foundation to Exonerate through Habeas Relief);
- 5. The President states that the name FEHR Foundation was coined by Jaime A. Davidson's attorneys, Mrs. Bettina Schein and Mr. Alan Futerfas (who also happens to be Board of Directors members), at FEHR Foundation, Inc.;
- 6: Moreover, the name FEHR Foundation, Inc. and Logo was registered by the President at the United States Library of Congress i.e., Copyright Registration Office on June 23rd, 2022;
- 7. On or around July 10, 2022, Mr. McCormack's wife, Annie M. Felipe blurted out of her mouth in front of her husband, Mr. McCormack to the President, "Gringo Man we're going to be 'MILLIONAIRES!. Immediately, the President noticed the look on Mr. McCormack's face to his wife, Mrs. Annie M. Felipe is highly upset. The President walked off now with Mrs. Felipe's assertion in his mind, that Mr. McCormack and his wife were going to utilize the President's FEHR Foundation to operate unlawfully:
- 8. In addition, the President began to look for his non profit organization documents to peacefully break ties from Mr. McCormack. The most important fact herein is that Mr. Laban J. McCormack was NEVER written and/or documented in the President's Sunbiz.org Division of Corporations legal papers as "The President." The record is blatantly clear that Mr. McCormack has ONLY been documented and/or recognized herein the President's FEHR Foundation legal papers as the "Registered Agent and/or Director:"
- 9. On or around July 17, 2022 at the Panamanian Hotel Torres de Alba (In Panama City, Panama, inside of the President's hotel room and in the presence of Mr. Juan Wood and Ms. Yesenia Trejos, Mr. McCormack for the second time disrespected Jalme A. Davidson in public i.e., talking to the President as though he was a 5 year old child screaming and shouting, extremely loud;
- 10. The President further asserts that the second disrespect committed by Mr. McCormack was the last time that he (Mr. McCormack), would disrespect the President in public again because that was the last straw that broke the Camel's back;
- 11. On or around August 2nd, 2022, Mr. McCormack called the President and asked why he hadn't gone to work? And, Jalme A. Davidson responded that he had quit and the President was taking his FEHR Foundation along with him (Jaime
- 12. On or around February 13, 2023, the President hired Northwest Registered Agent; LLC to reorganize Jalme A. Davidson's entire non profit organization, and most importantly, ALL of the Board of Directors and/or Members that Mr. McCormack had placed in the President's FEHR Foundation, Inc.; the President had DELETED ALL of them and REPLACED THEM with new members and Board of Directors, and Jalme A. Davidson as the PRESIDENT;

- 13. On or around February 13, 2023, the President filed a document titled, "Registered Agent Change FEHR Foundation, Inc.," where Mr. Laban J. McCommack's name was COMPLETELY REMOVED from being FEHR Foundation's Registered Agent, and hired Northwest Registered Agent LLC to represent the President in his non profit organization:
- 14. On or around March 21, 2023, the President once more changed from Registered Agent I.e., from Northwest Registered Agent LLC, to U-Post, LLC, where the changes of the new Registered Agent and Address occurred on or around April 10, 2023;
- 15. However, Jaime A. Davidson asserts for the record to reflect that Mr. Laban J. McCormack has NEVER held a position of President at the non-profit organization of FEHR Foundation, Inc.;
- 16. On or ground December 8, 2023, the President discovered while at the bank going to open up the business account for FEHR Foundation, Inc., that Mr. Laban J. McCormack had committed a serious case of FRAUD on August 9th, 2023 i.e., by filing a FALSE Article of Dissolution (Voluntary Dissolution), and the Fraudulent steps Mr. McCormack executed goes as follows:
- a. Mr. Laban J. McCormack knowingly, intentionally, willfully, and voluntarily MISREPRESENTED himself as the PRESIDENT of FEHR Foundation, Inc. i.e., with the sole and dominant purpose to Dissolve the President's non profit organization called, FEHR Foundation, Inc.;
- b. Mr. McCormack falsely stated, that "The date of the meeting of members at which the resolution to dissolve was adopted on August 8, 2023." For the record, one (1) Mr. McCormack DOES NOT know any of the new FEHR Foundation; inc. Directors and/or Members; two (2) Mr. McCormack has falsely stated that there was a meeting held without the President (Jaime A. Davidson), where the members joined Mr. McCormack's resolution to dissolve and it was adopted; and three (3) Mr. McCormack further falsely asserts that the President was out voted by the alleged number of votes cast by some fictitious members, which ended up being sufficient for their approval;
- c. Mr. McCommack boildly lied and asserted that he has submitted this document (his Articles of Dissolution), affirming that the facts stated therein were true and in all actuality, it's all false;
- d. Mr. McCormack further FALSELY stated that he, Mr. McCormack was aware that any false Information submitted in this document to the Department of State constitutes a "THIRD DEGREE FELONY" as provided for in Section 817.155, Florida Statutes and Mr. McCormack BLATANTLY & BOLD FACED committed a serious case of FRAUD against the Department of State, and most critically, Mr. McCormack has committed ALL such fraudulent acts knowingly and intentionally; and
- e. Last but not least, for the record, again, Mr. McCormack CANNOT show any documentation(s) where his name has been documented as being the PRESIDENT of FEHR Foundation, Inc.;
- 17. Therefore, Jaime A. Davidson, the rightful President of FEHR Foundation, Inc. respectfully submits this Statement of Facts i.e., in order that once this non profit organization is back active and properly running publicly, nobody else could commit another grave FRAUD by UNLAWFULLY tampering with the President's company, as Mr. Laban McCormack was able to enter into the Florida Department of State and execute a Criminally Punished SCAM & FRAUD, that's a 3rd Degree Felony; and
- 18. Furthermore, Jalme A. Davidson, the President will like the Florida Department of State to view a quick peek into the criminal mind that Mr. McCormack has and which led the President to sever ALL ties from under his control because the President personally witnessed how Mr. Laban McCormack was attempting to add individuals into Jalme A. Davidson's foundation in positions to be paid without doing any work (clearly committing various acts of FRAUD), and various other shady activities that the President witnessed that compelled Jalme A. Davidson to break all ties before it would've been too late. Mr. Laban McCormack's FRAUDULENT ACTS witnessed today is ONLY a small demonstration of how committing criminal acts don't stop Mr. McCormack acting under his legal status as an accountant with the McCormack Enterprises in New York and Caribbean Law & Taxes Services in Florida.
