ARTICLES OF INCORPORATION

of

**KEEP MOVING FORWARD FOUNDATION INC**  
(A Florida Not for Profit Corporation)

**Article I**  
**NAME**

The name of this corporation shall be KEEP MOVING FORWARD FOUNDATION INC (hereinafter called the "Corporation").

**Article II**  
**PRINCIPAL OFFICE AND/OR MAILING ADDRESS**

The address of the principal office and/or the mailing address of the Corporation is 19002 Park Ridge St, Weston, FL 33332.

**Article III**  
**PURPOSE**

This Corporation is a Not for Profit Corporation, organized for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations as defined in Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, as amended (the "Code"), including without limitation: Economic support to people and organizations with programs specifically designed for children, the elderly, and families in financial distress, providing them with food, health assistance and guiding them to reintegrate into society with a safe and stable environment.

**Article IV**  
**MEMBERSHIP**

This organization is not a membership based organization.

**Article V**  
**BOARD OF DIRECTORS**

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than three (3) directors. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less than three. The manner in which the directors are elected and appointed shall be regulated by the Bylaws. The initial directors are:

**Article VIII**  
**LIMITATIONS**


No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IX**  
**DISSOLUTION**

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


