

ARTICLE OF AMENDMENT E.
Amending and adding additional Articles,

ARTICLE III adding to:

The specific Purpose for which this corporation is organized is:

This corporation is organized and operated exclusively for religious, educational and charitable purposes within the section 501 (c) (3) of the Internal Revenue Code as an integrated auxiliary of Refuge Worship Center Ministries, Inc (A Religious Organization).

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code.

The property of this corporation is irrevocably dedicated to religious, charitable and educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer, or member thereof or the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non- profit fund, foundation, or corporation operated exclusively for Educational and Charitable purposes under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to Church or the federal government, or to a State or Local Government for a disposed of by the Court of the county in which the principal office of the organization is located, exclusive for such purposes or to such.

The manner in which the directors are elected or appointed:


