ARTICLES OF INCORPORATION

OF

Casa De Dios: Uncion Del Cielo Inc.

The undersigned acting incorporator(s) of a corporation pursuant to chapter 617, Florida Status, adopt(s) the following Articles of incorporation for such corporation and will be included in the By-Laws.

ARTICLE I

The name of the corporation shall be:

Casa de Dios: Uncion Del Cielo Inc

The principle place of business of the corporation shall be:

Ocala Fl. 34470

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose for which the corporation is organized are:

The primary, exclusive and only purposes for which this corporation is organized are religious ones, to wit:

- A. Provide a Church where members can fellowship one with another both in large public congregations and in small fellowship groups in house and other places, to worship GOD IN SPIRIT AND IN TRUTH and to cooperate in the building up of the body of Christ.
- B. To strengthen the members of the church and their families so that the home life of each member is healthy and fruitful by biblical standards.

- C. To perform the sacraments of the church which include: to baptize believers in waters by immersion, to celebrate the Lord's Supper and to perform other ministries, which include, but are not limited to anointing the sick with oil, conduct weddings and funerals, dedicate infants and any other practice approved in accordance with Scripture. Let it be made known that we believe that marriage is, according to the Bible, between a man and women.
- D. To license and ordain ministers to assist in the establishment and maintenance of other churches, or other institutions and to set forth and maintain ministers, missionaries or other workers for the establishment and up building of such churches, or institutions, whether domestic or foreign. The foregoing clauses are both purpose and power, and the foregoing enumeration of specific powers does not limit or restrict in any manner the powers of the Corporation.

ARTICLE IV

The qualifications for members and the manner of their admission are to be provided for in the bylaws of the corporation.

I-PURPOSE

The Board of Directors shall provide guidance, direction and assistance to the Senior Pastor and staff of Casa De Dios: Uncion Del Cielo Inc. To attain the goals and objectives set forth in Article III of the Articles of Incorporation of the church. This Board, by a majority vote of its membership and in cooperation with the Senior Pastor, shall establish the standards that shall govern the church operations. It is expressly understood that the Board's authority is to those areas of responsibility set forth in section III of the By-Laws and the administrative responsibility for the church operations is entrusted to the senior Pastor.

II- COMPOSITION/MEMBERSHIP

- A. **COMPOSITION**: The Board of Directors of Casa De Dios: Uncion Del Cielo Inc. shall be composed of five (5) voting members, and three (3) Ex-Officio members, for a total of eight (8) Directors. Membership shall be limited to this number until otherwise amended by (2/3) of the full voting membership of the Board. Ex-officio members will serve in an advisory capacity only and will not have voting privileges.
- B. **QUALIFICATIONS**: Members shall be faithful Christians of unquestionable character and reputation who are especially sensitive to the particular needs of the members of the church. They should be able and willing to devote the time and energies necessary to properly execute their duties. Ideally, membership should be drawn from various business backgrounds so the Board will benefit from multiple talents and viewpoints. Under God's direction, the Board should always keep the church's welfare as the focus of all business transactions.

- C. **SELECTION OF MEMBERS:** The initial Board of Directors shall be selected by invitation of the Board of Directors of Casa De Dios: Uncion Del Cielo Inc. Subsequent members will be selected and approved by a two-thirds majority vote of the current-voting members in good standing.
- D. **VACANCIES:** Vacancies may occur from time to time due to the permanent departure of a current member or because of the need to increase the overall number of membership. When such vacancies occur, every effort must be made to fill the vacancies within 30 days to ensure the business of the Board continues with minimum interruption. Any person who meets the qualifications may apply to the Board to fill existing vacancies. Equal consideration will be given to all applications regardless of race, creed, color, national origin, or denominational affiliation.

ARTICLE V

The number constituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons to serve are as follows:
