# Corporate Resolution Spanish American Club of Citrus County, Inc.

We, Members of the Spanish American Club of Citrus County, Inc., organized and existing under the laws of the State of Florida, and having our principal address at P.O. Box 2591, Inverness, Florida 34451 (the "Corporation"), do hereby consider and resolve the following:

#### **Considering That:**

- 1. No member accepts a nomination for President, Secretary and Treasurer at our May General Membership meeting as required by the Bylaws.
- 2. Members did not respond to a mailed request for volunteers to serve on the Board of Directors.
- 3. The current Board has served for 3 consecutive terms.
- 4. The Corporation Bylaws require the Board to dissolve the Corporation following all legal requirements, and the State of Florida requires that Board of Directors of non-profit corporation with active membership recommend dissolution to their membership in writing.
- 5. Our bylaws require corporate dissolution follow Robert's Rules of Parliamentary Procedure.
- 6. Roberts Rules requires dissolution resolutions to follow bylaw amendment procedures.
- 7. This resolution has been read at 2 consecutive meetings and notice of this vote has been mailed to all voting/active members.

#### We hereby Resolve:

- 1. That the Spanish American Club of Citrus County, Inc be dissolved effective May 30, 2023.
- 2. That consonant with our bylaws, the Board will continue active for 3 months following the May meeting conducting our corporate required reporting and finalizing all corporate business.
- 3. That all Corporate Assets shall be distributed and donated in the following manner:
  - a. Goods and furniture will be sold or given to non-profit organizations.
  - b. Our corporate accounts shall be closed prior to August 17, 2023.
  - c. A check for the full balance of funds shall be made for, and delivered to Jessie's Place, a non-profit organization of Citrus County, in accordance with our Certificate of Incorporation and our Bylaws.
- 4. That a copy of this resolution, our articles of Dissolution and the Asset Distribution Plan herein stated shall be mailed to the Florida Department of State and attached to our 990 Federal IRS Non-Profit yearly filing, to notify all pertinent government agencies of our dissolution.
- 5. That in the unforeseeable possibility that volunteers agree to assume the responsibilities of the 3 main executive positions of the Board of Directors, on or before August 17, 2023 this dissolution will be null and void.
- 6. That on August 17, 2023 the Board shall convene a meeting of Members to report on all the dissolution activities performed.
