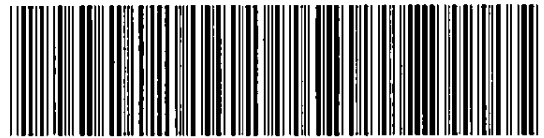

ARTICLES OF INCORPORATION

OF

GREATER MACEDONIA BAPTIST CHURCH, INC.
(A Corporation Not For Profit)

We, the undersigned, with other persons being desirous of forming a corporation for religious and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation is GREATER MACEDONIA BAPTIST CHURCH, INC.

ARTICLE II

Notwithstanding any other provisions of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

The general nature of the object and purpose of this corporation shall be for the sole purpose of furthering the Kingdom of God. It is the desire of said institution to become incorporated (chartered) under the laws of Florida as an institution not for profit. Said institution may hold property and transact business which is necessary in her endeavor of fulfilling the task as a Church.

The object, business, and purpose of this corporation is nonpolitical, and shall be devoted to promoting a spirit of brotherhood and a closer association between the members of the organization, and to uphold and maintain the Constitution of the

United States of America and all the subdivisions thereunder, and to assist in the maintaining of law and order; to safeguard and transmit to posterity and purity and righteousness of individual freedom, and the teaching of our order, as well as to teach the same to our individual members and to the community at large; to assist in charitable work of any nature deemed beneficial and to the best interests of the order and to society as a whole, and to raise funds for carrying the same into effect in any manner allowed by the constitution and the bylaws of the order, and permitted under the laws of the State of Florida and the Constitution of the United States of America.

ARTICLE III

The form of government of said body is theocratic. All bylaws for both faith and practice is contained in the Holy Scriptures which all members hold to be the utterances of God. In all matters both spiritual and temporal, the mind of the Lord shall be sought and followed.

To accomplish such objects, the corporation shall be authorized to receive gifts and contributions and shall be authorized to own property of every nature and kind whatsoever, real, personal and mixed.

ARTICLE IV

The members of this corporation shall consist of regular members. Regular members shall constitute all persons hereinafter named as subscribers, and such other persons resident in Florida as from time to time may become regular members in the manner provided in the By-laws and for the desire of coming together for the furthering of the Kingdom of God.

ARTICLE V

This corporation is to exist perpetually.

ARTICLE VII

The officers/^{Directors} of this corporation shall be a President, a Secretary, a Vice President and a Treasurer, and such other officers as may be provided in the By-laws.

The names of the persons who are to serve as officers of the corporation until their first meeting of the Board of Trustees are:

Edgar Lagressa Mathis - Treasurer

Waynetta McGraw - Secretary

The officers shall be elected at the annual meeting of the Board of Trustees or as provided in the By-laws.

ARTICLE VIII

The business affairs of this corporation shall be managed by the Board of Trustees, or by an executive committee, as may be provided by the By-laws, appointed by the Board of Trustees. This corporation shall have at least four Trustees initially. The number of Trustees may be increased from time to time, by the By-laws, to include the membership entire.

The Board of Trustees shall be members of the Church corporation.

Members of the Board of Trustees shall be elected and hold office in accordance with the By-laws.

ARTICLE X

These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a majority vote of those present. Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the By-laws, of intention to submit such amendments.

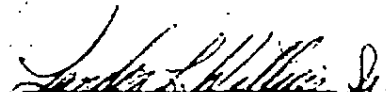

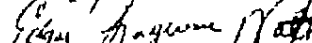
ARTICLE XII
