# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF



FIRST CHRISTIAN CHURCH AT LEESBURG, FLORIDA, INC.

(Corporation Document No. N22986)

Pursuant to and in compliance with the provisions of Section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

\*\* (c) The Qualifications of Members and the Manner of their Admission:

Add the following paragraph:

A dual membership classification shall be for those immersed believers who desire to unite with this Church on the above basis while continuing with their membership in another out-of-area church. This dual membership carries all the rights and privileges of regular membership.

### \*\* (g) <u>Directors</u>:

The first line of this section shall begin as follows:

The Elders shall be elected by the members of the Corporation at the annual meeting of the membership and shall hold office for such term as may be provided in the By-Laws.

The following portion shall be <u>removed</u>:

"In all instances involving the regular election of officers, such regular elections shall be held at a meeting of the full congregation at least thirty (30) days prior to the beginning of the term of such newly-elected officers;"

### \*\* (i) Amendments to Articles of Incorporation:

The first sentence in this section shall read as follows:

The Articles of Incorporation may be amended in the following manner: The Official Board shall be the Board of Directors consisting of the Eldership of the Church.

# \*\* (k) <u>Indebtedness</u>:

This section shall read as follows:

The highest amount of indebtedness or liability to which the Trustees/Board of Directors may subject this corporation shall not exceed ten percent of the current yearly budget. Any obligations in excess of said amount must have congregational approval as set forth in the By-Laws of this corporation.
