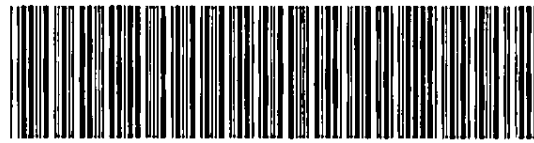



ARTICLES OF INCORPORATION
OF
GENERAL SERVICE DISTRICT 9, INC.

Pursuant to Section 617.0202 of the Florida Statutes, the undersigned for the purpose of forming a Florida not-for-profit Corporation, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The Name of this corporation is GENERAL SERVICE DISTRICT 9, INC (the Organization).

ARTICLE II – ADDRESS

ARTICLE III - PURPOSES

The purposes for which the organization is established are as follows:

To receive and to administer funds and to operate exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or comparable provisions of subsequent legislation and to give funds and property from time to time to other organizations to be used or held for use directly in carrying out one or more such purposes.

To do such things and to perform such acts to accomplish its purposes as the Board of Directors may determine to be appropriate and as are not forbidden by Section 501(c)(3) of the code, with all powers conferred on nonprofit corporations under the laws of the State of Florida.

Alcoholics Anonymous is a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism. The only requirement for membership is a desire to stop drinking. There are no dues or fees for AA membership; we are self-supporting through our own contributions. Our primary purpose is to stay sober and to help other alcoholics to achieve sobriety.

No part of the income or earnings of the Organization shall inure to the benefit of, or be distributed to, any director, officer, manager, or any other private individual in such a fashion as to constitute an application of funds not within the purpose of exempt organizations described in Code section 501(c)(3). Reimbursement for expenditures or the payment of reasonable compensation for services shall not be deemed to be a distribution of income or earnings.

No part of the activities of the Organization shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, except to the extent that the Company makes expenditures for purposes of influencing legislation in conformity with the requirements of Section 501(h) of the Code, and the Company shall neither participate nor intervene (including the publication or distribution of statements) in any political campaign on behalf of any candidate for public office any time.

In the event of the complete or partial liquidation or dissolution, whether voluntary or involuntary, no director, officer or manager of the Organization or any other private individual shall be entitled to any distribution or division of the Organization's proceeds. Such proceeds shall be distributed exclusively to an organization or organizations which themselves are exempt as organizations described in Code section 501(c)(3) or to a federal, state or local government, for a public purpose.

ARTICLE IV - DIRECTORS

The manner in which directors are elected or appointed is as provided in the Bylaws.

ARTICLE V - REGISTERED AGENT




