TO THE

Pursuant to the provisions of Section 607.1006, Florida Statutes, HUSSEIN FAMILY FOUNDATION, INC., a Florida not for profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is HUSSEIN FAMILY FOUNDATION, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on January 12, 2023.

ARTICLE II
Amendment

Article VIII of the Articles of Incorporation of this Corporation is hereby amended for the purposes of changing the dissolution clause of the Corporation by deleting the existing Article VIII in its entirety, and substituting the following:

• *ARTICLE VIII*
Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code; or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."

ARTICLE III
Date of Adoption

The amendment was adopted on the 6th day of June, 2024.

ARTICLE IV
Manner of Adoption

There are no members or members entitled to vote on the Amendment. The Amendment was adopted by the board of directors.
