ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to Section 607.1006, Florida Statutes, TERRACES AT ROYAL PALMS TOWNHOMES HOMEOWNERS ASSOCIATION, INC., a Florida not for profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The Articles of Incorporation of the Corporation were filed on April 28, 2023, and assigned Florida Document No. N23000005335.
