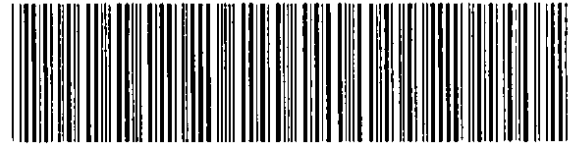

## **ARTICLES OF INCORPORATION**

**OF**

### **HIS SHED BLOOD MINISTRIES INC**

The undersigned, acting as incorporator of a domestic nonprofit corporation in compliance with Florida Chapter 617, F.S.. (Not for Profit), adopt the following Articles of Incorporation:

#### **ARTICLE 1: CORPORATE NAME**

The name of the corporation is His Shed Blood Ministries Inc and shall also be known as His Shed Blood or His Shed Blood Ministries.

#### **ARTICLE 2: MISSION & PURPOSE**

It is our hearts desire at His Shed Blood Ministries Inc to bring people into the Kingdom of God through signs, wonders and miracles as demonstrated by the life of Jesus and to see the body of Christ equipped, healed and delivered.

The organization will fulfill its mission and purpose by providing religious, faith-based programs and training to the body of Christ through local church settings, crusades, mission trips and conferences both home and abroad. In addition, the organization will host His Shed Blood School of Supernatural Ministry to educate the body of Christ in gifts of the spirit, the prophetic, the baptism in the Holy Spirit, street evangelism and healing and deliverance to include physical, spiritual, mental, emotional and financial breakthrough in the body of Christ. We will spread the gospel of Jesus Christ that teaches the word of God and takes that message to the nations.

#### **ARTICLE 3: POWER**

His Shed Blood Ministries Inc is organized exclusively for charitable, religious and nonprofit purposes. We anticipate donor contributors and sponsors to aide in this pursuit. The organization will engage in charitable activities permissible under section 501(c)(3), such as receiving and giving donations, advancement of religion, and public charitable programs.

No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

His Shed Blood Ministries Inc is not organized for profit, and no part of the net earnings of this corporation shall inure to the benefit, or be distributable to its members, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

The corporation shall never be operated for the primary purpose of carrying on a trade or business for profit. Notwithstanding any provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law) or contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE 4: DURATION & PHYSICAL YEAR**

The period of duration for this corporation shall be perpetual or until such time as the Board of Directors shall adopt a resolution recommending that the corporation be dissolved.

The month of the physical year close shall be December.

**ARTICLE 5: REGISTERED AGENT**

#### **ARTICLE 12: INDEMNIFICATION**

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

#### **ARTICLE 13: LIMITATIONS AND RESTRICTIONS**

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### **ARTICLE 14: INTENT & STOCK**

This corporation intends to be a religious, faith-based charitable organization and therefore shall not have authority to issue capital stock.

#### **ARTICLE 15: DISSOLUTION**

The corporation shall use its funds only to accomplish the purposes stated in these Articles of Incorporation. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to, and only to, one or more charitable organizations with exempt purposes.

#### **ARTICLE 16: BY-LAWS**

The Board of Directors shall have the power to adopt, amend or repeal the By-Laws of this corporation. The By-Laws shall govern the operation of this corporation unless any By-Law conflicts with these Articles of Incorporation, in which case the Articles of Incorporation shall be controlling.

#### **ARTICLE 17: BELIEF STATEMENTS**
