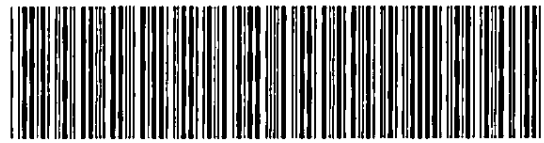

Article I - Name

The name of the corporation shall be Living Waters: A Christian Ministry to the Educational Community, Incorporated.

Article II – Principal Office

The principal street address is 142 Fairview Avenue, Daytona Beach, FL 32114. The principal mailing address P.O. Box 285, Daytona Beach, FL 32115.

Article III - Purpose

Living Waters: A Christian Ministry to the Educational Community, Incorporated is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose for which the corporation is organized is to establish a non-denominational Christian ministry of prayer, fellowship, and service to encourage and inspire the educational community.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
