

(to be added) This Corporation is organized and operated exclusively for the purpose of acquiring funds and other appropriate assets from individuals, firms, foundations, corporations, other entities, governmental bodies and all segments of the public in general, by active solicitation. Its primary mission is to improve the delivery of health care at University of Miami/Jackson Memorial Medical Center (sometimes "UM/Jackson"); support medical and surgical treatment at UM/Jackson; and to help maintain, construct, repair, equip and furnish the facilities of UM/Jackson. The Foundation will also support when possible, instruction and training of personnel in the duties of medicine and nursing and support teaching and training programs in health care at UM/Jackson. The funds raised by the Foundation are intended to supplement and not supplant traditional funding sources, including agencies of federal, state or local governments.
