Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

ARTICLE III B, PURPOSES AND POWERS, is hereby amended to delete its current language and to read as follows:

The Jackson Memorial Foundation, Inc. (the "Foundation" or the "Corporation") is a private, non-profit corporation organized and operated principally for the purpose of acquiring funds and other appropriate assets individuals, firms, foundations, corporations, other governmental bodies and all segments of the public in general, by active solicitation. Its mission is to support the improvement of the delivery of health care by the Public Health Trust of Miami-Dade County, doing business as the Jackson Health System ("JHS"). The Foundation focuses on the University of Miami/Jackson Memorial Medical Center ("UM/Jackson"), the campus of Jackson Memorial Hospital and the Leonard M. Miller School In furtherance thereof, the of Medicine of the University of Miami. Foundation also supports promotion, development and non-medical customer service in connection with medical and surgical treatment at UM/Jackson; helps maintain, construct, repair, equip and furnish the facilities of UM/Jackson; and provides, upon request by JHS, support services for JHS when such services are performed by foundations similar to the Foundation

and which complement the Foundation's fund-raising mission and activities. The Foundation will also support, when possible, instruction and training of personnel in the duties of medicine and nursing and support teaching and training programs in health care at UM/Jackson. The funds raised by the Foundation are intended to supplement and not supplant traditional funding sources, including agencies of federal, state or local governments.
