ARTICLE III PURPOSE:

OUR MISSION IS TO BENEFIT THE COMMUNITY OF NAS SIGONELLA BY EDUCATING THE PUBLIC ON HUMANE PRINCIPLES OF RESPONSIBLE ANIMAL OWNERSHIP, PREVENTING ANIMAL CRUELTY AND MITIGATING PET ABANDONMENT. WE ADVOCATE FOR THE WELLBEING AND HUMANE TREATMENT OF STRAY ANIMALS WITHIN SIGONELLA AND PROVIDE COMMUNITY OUTREACH PROGRAMS AND HOST EVENTS TO TEACH HUMANE PRINCIPLES, AND TO PREVENT ANIMAL CRUELTY OR ABANDONMENT.

OUR CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL AND SCIENTIFIC PURPOSES, INCLUDING FOR SUCH PURPOSES, THE MAKE OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 C 3 OF THE INTERNAL REVENUE CODE.

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES OR OFFICERS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSES SET FORTH ABOVE.
