



**FIRST.** The name of the corporation shall be:

'SHRINE OF FATIMA AND SAINT CAJETAN, INC.'

**SECOND.** This nonstock corporation is organized exclusively for religious, charitable, scientific and educational purposes including, but not limited to, the ownership and operation of religious worship facilities and the doing of all things necessary and proper therefore. In carrying out these purposes, the Corporation shall hold and exercise all of the authority granted to nonprofit corporations under Florida law as it may from time to time exist. The foregoing notwithstanding, the Corporation is not formed for the pecuniary gain or profit of, and neither its net earnings nor any part thereof shall be distributable to its members, trustees, officers, or other individuals; nor shall it engage in any activity which is not permitted to be carried on by a corporation which is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code of 1954 as amended or any other provision of federal income tax laws and/or regulations of the Internal Revenue Service.

**THIRD.** The qualifications for members and the manner of their admission shall be as follows:

- 1) The sole initial member shall be as set forth in item Seventh, below.
- 2) Upon the death, disability or resignation of the initial member, Father Elmer Vida, Traditional Bishop, Albany, New York, shall assume the position of sole member of the Corporation.
- 3) If Fr. Vida shall predecease the sole initial member, or refuse the position, or, after having assumed the sole membership, shall die, become disabled or resign, then the successor member shall be the 'Society of St. Pius, X', of Ecône, Switzerland.
- 4) If the 'Society of St. Pius, X' shall refuse the position, or having accepted shall resign, dissolve or otherwise not be able to continue in that capacity, then such tax exempt organization as the Board of Trustees may choose, subject to the current Member's approval, or if there is no Member, then subject to the

- 2) The purchase, sale, lease, disposition or hypothecation of any real and/or personal property by the corporation.

- 4) The amendment of these Articles of Incorporation, and the adoption and any subsequent amendment of the Code of Regulations and of any Bylaws.




