ARTICLES OF INCORPORATION

ARTICLE III PURPOSE

The purpose for which the corporation is organized is exclusively for charitable, educational, and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code. These purposes may be pursued through programs and activities including, but not limited to, funding, counseling, therapies, mental health services, and/or research.

ARTICLE III.2 DISSOLUTION OF ASSETS
