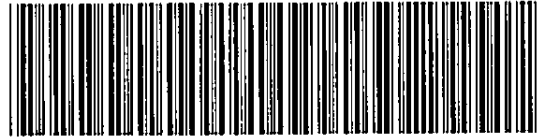

THE UNDERSIGNED hereby makes, subscribes, acknowledges and files these Articles of Organization of **COSTA RICA CHAMBER OF COMMERCE USA FOUNDATION INC.**, a Florida Not-For-Profit corporation, formed under of Chapter 617, Florida Statutes, the Florida Not For Profit Corporation Act ("Act").

ARTICLE I - Name:

The name of the Not-For-Profit Corporation is "**COSTA RICA CHAMBER OF COMMERCE USA FOUNDATION INC**" (the "Not-For-Profit Corporation").

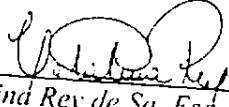
