

The Articles of Incorporation of The Faith Center for Leadership Development, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Non-profit Corporation Law of Chapter 617, Florida Statues, do hereby certify:

Article One: The name of the Corporation shall be <u>The Faith Center for Leadership</u> <u>Development, Inc.</u>

Article Two: The place in this state where the principal office of the Corporation is to be located is 6600 Willow Street Mount Dora, FL. 32757.

Article Three: The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
