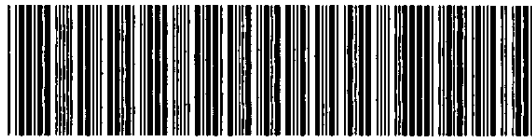

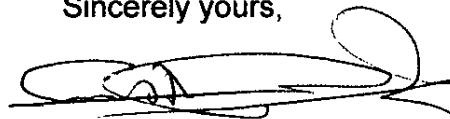

AMENDMENT OF ARTICLES OF INCORPORATION  
OF

CRYSTAL GLEN PROPERTY OWNERS ASSOCIATION, INC.

WHEREAS, Crystal Glen Property Owners Association, Inc. was duly filed with the Florida Secretary of State's Office on March 28, 1988; and

WHEREAS, it has become necessary to amend the Articles of Incorporation and as provided under Article XIII, by a Resolution proposed by the Board of Directors approved by the majority of the members of the dwelling units in Crystal Glen Subdivision at a duly notice meeting at which a quorum was present on August 18, 2007; and

NOW, therefore, be it resolved that:

Accordingly, the Articles of Incorporation of Crystal Glen Property Owners Association, Inc. are amended as follows:

1. Article V is amended by the addition of a new paragraph to read as follows:

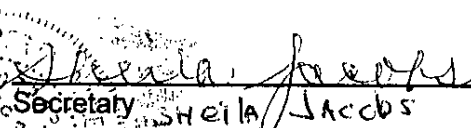
C. Corporate Board Membership. Subsequent to the Board of Directors being made up of Developers and being replaced by the lots owners themselves, no two members of the elected board from the same lot owner/household shall serve on the board during the same elections cycle.

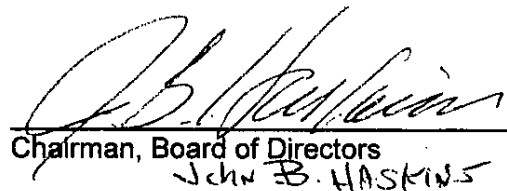
2. Article XIII is amended to strike the word "Oaks" as it is a typographical error and insert the word "Glen" to correctly reflect the proper subdivision name and Article XIII is hereby amended to read as follows:

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote; provided, however, that any amendments hereto shall require the approval of the majority of the members of the dwelling units in Crystal Glen Subdivision.

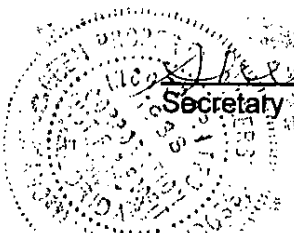

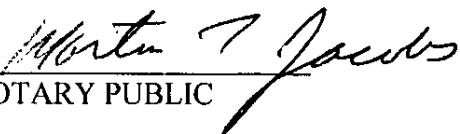
