Pursuant to the provisions of Section 617.1006, Fla. Stat. (2013) CRYSTAL GLEN PROPERTY OWNERS' ASSOCIATION, INC. adopts the following amendments to its Articles of Incorporation.

1. ARTICLE V, Management of Corporate Affairs, shall read as follow:

## ARTICLE V MANAGEMENT OF CORPORATE AFFAIRS

A. Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors comprising only members of the Corporation. The Board shall consist of the number of Directors as provided in the By-Laws, but which shall consist of not less than three Directors and which shall always be an odd number.

Directors shall be elected at the Corporation's annual meeting, and shall serve for a term as provided in the By-Laws. Each Director shall serve until his successor shall be elected and shall qualify. Annual meetings of the membership shall be held within the first three (3) months of each fiscal year at the principal office of the corporation, or at such other place or places as the Board of Directors may designate from time to time.

- B. Corporate Officers. The Board of Directors shall elect the following officers: President, Vice President, Secretary, Treasurer, and such other officers as the By-Laws may authorize the Directors to elect from time to time. Officers shall be elected as provided in the By-Laws.
- C. Corporate Board Membership. Subsequent to the Board of Directors being made up of Developers and being replaced by the lots owners themselves, no two members of the elected board from the same lot owner/household shall serve on the board during the same elections cycle.
- 2. The foregoing amendment was adopted by an affirmative vote of a majority of all lot Owners within the Crystal Glen Subdivision on August **29**, 2013.
