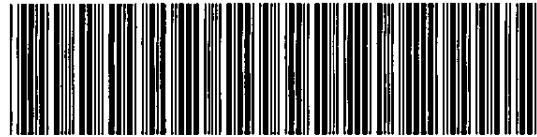

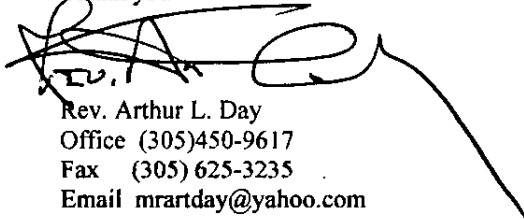
In reference to our conversation earlier today. Enclosed you will find the amendment for the Articles of Incorporation for Gethsemane Missionary Baptist Church.
