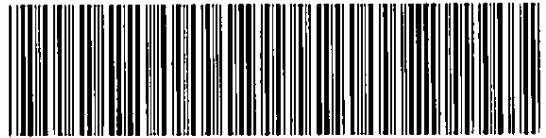

ARTICLES OF INCORPORATION

OF

FIRST UNITED METHODIST CHURCH OF VERO BEACH, INC.
(A Florida Not-For-Profit Corporation)

I, the undersigned, acting as incorporator for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, pursuant to Chapter 617, Florida Statutes, hereby certify as follows:

ARTICLE I

Name

The name of the corporation shall be:

FIRST UNITED METHODIST CHURCH OF VERO BEACH, INC.

ARTICLE II

Purpose

The purpose for which the corporation is organized is exclusively church related within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law. Its activities shall be conducted in such a manner that no part of its net earnings shall inure to the benefit of any member, director, trustee, officer or individual. It shall not have the power to issue certificates of stock or declare dividends.

Notwithstanding any provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3), or by a corporation qualified as a public charity under Section 509(a), of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Without in any way limiting the foregoing general purpose, the specific purpose of the corporation shall be religious, and any and all other lawful purpose or purposes for which a not-profit corporation may be organized: provided, however, that the corporation shall not engage in activities that are not in

furtherance of its charitable and educational purposes other than as an insubstantial part of its activities.

No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

ARTICLE III

Powers

The corporation shall possess and may exercise all the powers and privileges granted by Chapters 607 and 617 of the Florida Statutes, or by any other law of Florida, together with all powers necessary or convenient to the conduct, promotion or attainment of the activities or purposes of the corporation, limited only by the restrictions set forth in these Articles of Incorporation. Such powers shall include, but not be limited to, the power to sue and be sued, to contract and be contracted with, and to acquire, purchase, hold, lease, sell, mortgage and convey such real and personal property as the Board may deem proper or expedient to carry out the purposes of the corporation; provided, however, that the corporation shall not engage in activities that are not in furtherance of its charitable purposes other than as an insubstantial part of its activities.

ARTICLE IV

Term

The term of the corporation shall be perpetual.

ARTICLE V

Directors

6.1 Number.

The affairs of the corporation are to be managed by a Board of Directors consisting of nine (9) members.

6.2 Powers.

The Board of Directors shall act for the corporation and shall have the power to decide all matters relating to the conduct of business for the corporation.

6.3 Initial Board.

The initial Board of Directors of the corporation shall consist of eight (8) members.

Bylaws

The Bylaws of the corporation shall initially be made and adopted by its first Board of Directors. The Bylaws may thereafter be altered, amended, or repealed, and new and other Bylaws may be made and adopted by the Board of Directors as provided and subject to such restrictions as may be set forth in the Bylaws.

ARTICLE IX

Amendments

Amendments to these Articles of Incorporation may be made and adopted only by the vote of at least five (5) of the members of the Board of Directors of the corporation. Amendments shall be effective when a copy thereof, properly executed and acknowledged, has been filed with the Department of State and all filing fees paid.

ARTICLE X

This refers to the information submitted for use in determining your status and the status of your affiliated religious organizations, on the list you submitted, as being exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

For the purposes of this group ruling, your affiliated religious organizations include The General Conference, Judicial Council; General Agencies, Commissions, Committees, their divisions and departments thereof, and other related organizations; Jurisdictional Conferences and Affiliated Agencies, Commissions, and other organizations; Annual Conferences and divisions and departments thereof; Annual Conference Agencies, Commissions, Committees, and affiliated organization; Local Churches and Local Church Agencies, Commissions, Committees, and other affiliated organizations.

Based on the information supplied, we rule that you and your affiliated religious organizations, on the list you submitted, are exempt from Federal income tax under section 501(c)(3) of the Code.

We have further determined that you and the affiliated religious organizations you operate, supervise, or control, and which are covered by your notification to us, are not private foundations within the meaning of section 509(a) of the Code, because you and your affiliated religious organizations are organizations described in sections 170(b)(1)(A)(i) and 509(a)(1) of the Code.

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, they are not automatically exempt from other Federal excise taxes.

You and your affiliated religious organizations are not required to file the Return for Organizations Exempt From Income Tax, Form 990, as you come within the exception contained in section 6033(a)(2)(A)(i) of the Code.

You and your affiliated religious organizations are not required to file Federal income tax returns unless you are subject to the tax on unrelated business income under section 511 of the Code. If you or your affiliated religious organizations are subject to this tax, you must file an income tax return on Form 990-T. In this letter we are not determining whether any of your present or proposed activities, or those of your affiliated religious organizations, is unrelated trade or business as defined in section 513 of the Code.

You and your affiliated religious organizations are not liable for social security (FICA) taxes unless you file a waiver of exemption certificate as provided in the Federal Insurance Contributions Act. You and your affiliated religious organizations are not liable for the taxes imposed under the Federal Unemployment Tax Act (FUTA).

Donors may deduct contributions to you and to your affiliated religious organizations as provided by section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to or for your use, or to or for the use of your affiliated religious organizations, are deductible for Federal estate and gift tax purposes under section 2055, 2106, and 2522 of the Code.

If you change your purposes, character, or method of operation, please let your key District Director know so he may consider the effect on your exempt status. Also, please keep him informed of any changes in your name or address.

identification numbers, of your affiliated
religious organizations that during the year:
 - a. changed names or addresses;
 - b. were deleted from your roster; or
 - c. were added to the roster.
3. For affiliated religious organizations to
be added attach:
 - a. a statement that the information
upon which your present group
exemption letter is based applies;
 - b. a statement that each has given you
written authorization to add its
name to the roster;
 - c. a list of those to which the Ser-
vice previously issued exemption
rulings or determination letters; and
 - d. a statement that none of the
affiliated religious organization
are private foundations as defined
in section 509(a) of the Code.

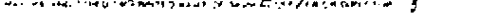
