ARTICLES OF AMENDMENT
OF THE
ARTICLES OF INCORPORATION OF MATANZAS SHORES OWNER'S ASSOCIATION, INC.

THIS SECOND AMENDMENT to the Articles of Incorporation of Matanzas Shores Owner's Association, Inc. ("Association") is made by the undersigned officers of the Association who certify that the following amendments were approved by not less than eighty percent (80%) of all directors at a duly-noticed meeting of the Board of Directors held on MARCH, 24, 2017 at which a quorum was attained. There are no members entitled to vote on this amendment.

ARTICLE IV
BOARD OF DIRECTORS


Section 1 is deleted in its entirety and replaced with the following (substantial rewording of article. See Article IV, Section 1 for present text):

Section 1. Number of Directors. The Association shall be governed by a Board of Directors comprised of at least five (5) directors. The specific number of directors and election procedures shall be set forth in the Bylaws.

~~Section 2. Class A Election of Directors.~~ At the first Annual Meeting after the Company has conveyed thirty three percent (33%) of the Units in the Property and at all Annual Meetings thereafter until the Turnover Meeting described in Section 3 below, the number of Directors shall be increased to five and the Class A Members of the Association shall elect two Directors and the Declarant shall appoint three directors.
