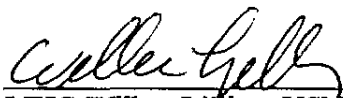
1. THE PALM BEACH AREA CHAPTER OF THE MILITARY OFFICERS ASSOCIATION OF AMERICA, Inc.
