

ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed on June 27, 1988. Document Number N27181.

FIRST: The name of the Corporation is Lighthouse Learning Center, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by the Corporation.

ARTICLE I - NAME

Change in the name of the Corporation:

From: Lighthouse Learning Center, Inc.

To: Children's Lighthouse Fund, Inc.

ARTICLE V - MANAGEMENT OF CORPORATE AFFAIRS

Henceforth, the term "Board of Trustees" shall be revised and replaced with the term "Board of Directors". Henceforth, the term "Trustee" shall be revised and replaced with the term "Director".

All references to "Board of Trustees" and "Trustees" shall be changed to "Board of Directors" and "Directors", respectively, in the Articles of Incorporation and in the Bylaws of the Corporation.

The minimum number of Directors shall be three (3).

With the exception of the above noted changes, the balance of Article V shall remain unchanged.

THIRD: These amendments were approved by a unanimous vote of the Directors of the Corporation, which was a sufficient number to approve these amendments, on the 10 day of January, 2006. This Corporation has no Members.
