ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF WILLOW RUN HOMEOWNERS ASSOCIATION, INC.

FILED 98 OCT 13 PM 3: 37 SECRETARY OF ST.

This first Amendment to the Articles of Incorporation of the WILLOW RUNS HOMEOWNERS' ASSOCIATION, INC. made this 9th day of September 1998. The Board of Directors, pursuant to Article X of the Articles, and pursuant to a vote of not less than 75% of the entire membership of the Board of Directors and not less than 51% of the votes of the entire membership of the Association, the following amendments have been made to the Articles of Incorporation:

1. Article IV, Definitions, Subsection D is amended to read as follows:

Lot shall mean and refer to any plot of land, or any inseparable combination of plots, showed upon the plat of Willow Run, Plat Book 30, Page 58, Public Records of Seminole County, Florida.

2. Article VII, Directors, Subsection 7.1, is amended to read as follows:

The affairs of the Association shall be managed by a Board of Directors who shall be members of the Association. The Board of Directors shall consist of six (6) members. Each of the six (6) members shall be elected for a staggered two (2) year term.

- 3. Article IX, Bylaws, Subsection (c) is amended to read as follows:
- (c) In the alternative, an amendment may be made by agreement signed and acknowledged by all lot owners in the manner required for the execution of the Deed, and such amendment shall be effective when recorded in the Public Records of Seminole County, Florida.

Provided, however, that no amendment shall discriminate against any lot owner nor against any lot or class or group of lots unless the lot owner or class or group of lot owners so affected shall

consent. No amendment shall be made that is in conflict with the Declaration of Covenants, Conditions and Restrictions or the Articles of Incorporation.

4. Article X, Amendments, subsection 10.3, is amended to read as follows:

Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of the members, without approval in writing by all members. No amendment shall be made that is in conflict with the Declaration of Covenants, Conditions and Restrictions.

5. These Articles of Amendment were adopted by the Directors and members of the Willow Run Homeowners' Association, Inc. on or about April 1998 as reflected in the appropriate Written Action Minutes.
