# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF WILLOW RUN HOMEOWNERS ASSOCIATION, INC.

04 FEB -5 PM 1: 10

This second Amendment to the Articles of Incorporation of the WILLOW RUN HOMEOWNERS' ASSOCIATION, INC. made this 10 day of 0 cohec, 2003. The Board of Directors, pursuant to Article X of the Articles, and pursuant to a vote of not less than 75% of the entire membership of the Board of Directors and not less than 51% of the votes of the entire membership of the Association, the following amendments have been made to the Articles of Incorporation:

- 1. Article VII, Restrictive Covenants, is amended to read as follows:
  - Section 14: Maintenance of Lots. Delete wording of current paragraph 14
    Add new paragraphs 14a, 14b and 14c as follows:
- 14a. Maintenance of land: All plants, shrubs, trees, grass and landscaping on a lot shall be maintained by each lot Owner in a trimmed and neat condition at all times. The Lot must be kept in good condition and repair and in conformity with the general character and quality of association properties. Examples include replacing dead/dying plants and grass, lawn mowing, trimming trees and shrubs (particularly over sidewalks) and cleaning concrete.
- 14b. Maintenance of Homes/Structures: Homes and Structures shall be maintained in good condition and repair, including repainting as necessary. Examples include gutters, exterior wood, downspouts, mailboxes, fences, garage doors, masonry walls, front doors.
- 14c. Changes to Homes/Structures and Lots. Exterior repainting of maintenance that involves no change in color from the current structure may be accomplished without approval of the ARB. Any other redecorating, alteration, repair, or improvement which changes the external

appearance, including color, of a dwelling requires ARB approval in the same manner as new construction. Examples are the replacement of roofs, rain gutters, downspouts, exterior walls or changing windows, doors, walks, drives, parking areas and other exterior portions of the lot.




