## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed January 3, 1989, #N29994. The date of adoption of these Articles of Amendment to Articles of Incorporation shall be February 9, 1998.

WHEREAS, on January 27, 1997, the Board of Directors of Orangewood Acres Homeowner's Association, Inc., a Florida not-for-profit corporation did file Articles of Amendment to Articles of Incorporation of Orangewood Acres Homeowners' Association, Inc., modifying Article II, Principal office, and Article VIII, Board of Directors; said document having been filed April 11, 1997 and recorded in the Office of the Florida Department of State, Document # N29994.

WHEREAS, the Board of Directors of Orangewood Acres Homeowners' Association, Inc., a Florida not-for-profit corporation has reviewed said Articles of Incorporation, as Amended, and desire to substantially modify the Articles of Incorporation, as Amended, to include additional modifications; and

WHEREAS, it would be in the best interest of the homeowners and members of the Orangewood Acres Homeowners' Association, Inc., a Florida not-for-profit corporation to substantially and entirely amend the Articles of Incorporation referenced herein;

NOW, THEREFORE, in consideration of the foregoing, the Board of Directors of Orangewood Acres Homeowners' Association, Inc., a Florida not-for-profit corporation hereby amend the Articles of Incorporation in its entirety, adopted February 9, 1998, as follows:

### "ARTICLES OF INCORPORATION OF

ORANGEWOOD ACRES HOMEOWNERS' ASSOCIATION, INC. (a Florida Not-For-Profit Corporation)

#### ARTICLE I NAME

The name of the association is ORANGEWOOD ACRES HOMEOWNERS' ASSOCIATION, INC., a Florida Not-for-Profit Corporation.

#### ARTICLE II PRINCIPAL OFFICE

The principal office of the association is located at 2552 North Orangewood Street, Avon Park, Florida 33825.

#### ARTICLE III REGISTERED AGENT

The street address of the Registered Office of the association is 143 South Ridgewood Drive, Sebring, Florida 33870, and the name of the Registered Agent is J. WENDELL WHITEHOUSE.

### ARTICLE IV DEFINITIONS

All definitions in the Declaration of Restrictions as amended, to which these Articles are attached as Exhibit "A" and recorded in the Public Records of Highlands County, Florida, are incorporated herein by reference and made a part hereof.

### ARTICLE V PURPOSE OF THE ASSOCIATION

This association does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for operation, maintenance and preservation of the real property and improvements thereon, described in the "Declaration of Restrictions" as amended to which these Articles are attached as Exhibit "A", as recorded in the Public Records of Highlands County, Florida, (hereinafter referred to as the "Declaration"), and to promote the health, safety and welfare of the members of the Association.

### ARTICLE VI POWERS OF THE ASSOCIATION

The Association shall have all the powers given under Florida Law to corporations to reasonably operate the Association, including but not limited to, the following:

- (a) Exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in the DECLARATION as amended;
- (b) Fix, levy, collect and enforce payment by any lawful means, all charges or assessments under the DECLARATION as amended;
- (c) Operate, maintain, sell, lease or transfer property in connection with the affairs of the Association;
- (d) Borrow money, and mortgage any or all of its real property as security for money borrowed or debts incurred;
- (e) To contract for management of the Association and to delegate in such contract all or any part of the powers and duties of the Association, and to contract for services to be provided the Owners including, but not limited to, maintenance, utilities and master antenna or cable television/radio system.

### ARTICLE VII MEMBERSHIP

The owner(s) of every Unit in the real property included in the Declaration as amended shall be a member of the Association. Membership shall be appurtenant to and may not be separated from ownership of any Unit.

### ARTICLE VIII BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of Directors consisting of seven (7) persons who must be members of the Association.

The Directors named in these Articles shall serve until the first election of Directors, and any vacancies in their number occurring before the first election shall be filled by the remaining Directors. The foregoing rights shall be in addition to, and not exclusive of, all other rights to which such Directors or Officers may be entitled.

# ARTICLE XV TRANSACTIONS IN WHICH DIRECTORS OR OFFICERS ARE INTERESTED

No contract or transaction between the Association and one (1) or more of its Directors or Officers, or between the Association and any other corporation, partnership, association, or other organization in which one (1) or more of its officers or directors are Officer or Directors of this Association shall be invalid, void or voidable solely for this reason, or solely because the Officer or Director is present at, or participates in, meetings of the Board or Committee thereof which authorized the contract or transaction, or solely because said Officers' or Directors' votes are counted for such purposes. No Director or Officer of the Association shall incur liability by reason of the fact that said Director or Officer may be interested in any such contract or transaction.

Interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a Committee which authorized the contract or transaction."


