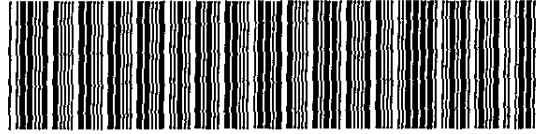

We hereby delete Amendment one (1) from the original Articles of Incorporation and replace it with the following:

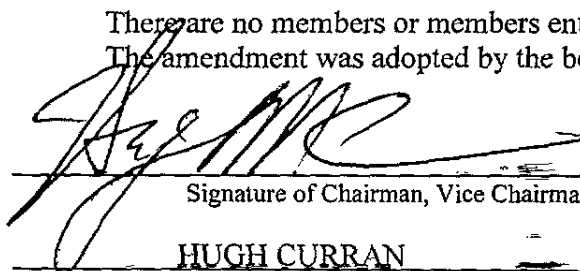
