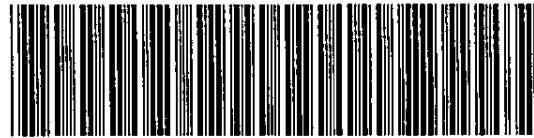


This corporation is changing the corporate name to be **LAKWOOD RANCH LITTLE LEAGUE, INC.** effective May 4, 2012.
