AMENDMENTS TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF KNIGHTSBRIDGE OF THE POLO CLUB HOMEOWNERS ASSOCIATION, INC.

The original Declaration of Restrictions and Protective Covenants for Knightsbridge of the Polo Club is recorded in Official Records Book 6204, at Page 1947, of the Public Records of Palm Beach County, Florida. The Amended and Restated Declaration of Restrictions and Protective Covenants for Knightsbridge of the Polo Club is recorded in Official Records Book 16454, at Page 1548, of the Public Records of Palm Beach County, Florida.

As indicated herein, words underlined are added and words struck through are deleted.

Item 1: Article III, Section 2 of the Amended and Restated Articles of Incorporation of Knightsbridge of the Polo Club Homeowners Association, Inc. ("Articles") shall be amended as follows:

Section 2. Voting Rights.

Members shall be all those owners as defined in Section 1. Members shall be entitled to one vote for each lot in which they hold the interests required for membership by Section 1. When more than one person, a corporation or a trust holds such interest or interests in any lot, all such persons and entities shall be members. The vote for such lot shall be exercised by one (1) person on behalf of the Lot, who shall be designated to vote for said Lot by the coowners of that Lot in such co-owners sole and absolute discretion. only by that one person designated in writing in a certificate signed by all lot owners or, in the case of a corporation or trust, by an appropriate officer of the corporation or the trustee or person designated in the trust. However, where a lot is owned by a husband and wife; no voting certificate shall be necessary, and the vote for the lot shall be cast as determined by the husband and wife. Additionally, any non-Member who is granted the membership rights pursuant to Section 1 herein shall be considered a multiple Member under this Section 2 and not a husband or wife, for the purposes of requiring a voting certificate. In no event shall more than one vote be cast with respect to any such lot.

Item 2: Article III, Section 3 of the Articles shall be amended as follows:

Section 3. Meetings of Members. The Bylaws of the Association shall provide for an annual meeting of members, and may make provision for regular and special meetings of members other than the annual meeting. A quorum for the transaction of business at any meeting of the members shall exist if thirty percent of the total number of members in good standing shall be present in person or by proxy.

Item 3: Article IX of the Articles shall be amended as follows:
