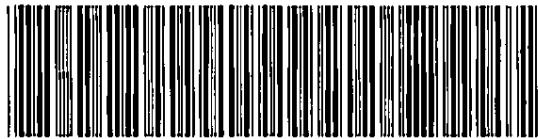

ARTICLES OF INCORPORATION
OF

THE VILLAGE AT SCOTT LAKE HOMEOWNERS' ASSOCIATION, INC.

We, the undersigned, acknowledge and file in the office of the Secretary of State of the State of Florida, for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

ARTICLE I.

The name of this corporation shall be THE VILLAGE AT SCOTT LAKE HOMEOWNERS' ASSOCIATION, INC., and the principal office shall be in Lakeland, Polk County, Florida, at 200 Lake Morton Drive.

ARTICLE II.

The purposes for which the corporation is organized are as follows:

(A) To provide for the establishment, maintenance, preservation and architectural control of any and all yards, all common areas, parks, greenways and roadside clearings located in that certain subdivision being developed near the City of Lakeland, Polk County, Florida, which subdivision is known as THE VILLAGE AT SCOTT LAKE, for the mutual benefit of the residents of said THE VILLAGE AT SCOTT LAKE to protect the value of their property and to engage in such other activities which may be of mutual benefit to the property owners in THE VILLAGE AT SCOTT LAKE. To operate and maintain the surface water management system as permitted by the Southwest Florida Management District including all lakes, retention areas, culverts and related appurtenance. For these purposes, the corporation is to do, to the extent a corporation organized under the Laws of the State of Florida may now or hereafter lawfully do, either as principal or agent and either alone or in conjunction with any other corporation, firm, partnership, association or individual, all and everything necessary or proper for the accomplishment of any of the purposes of any one or more of the objects hereinabove enumerated, or designed directly or indirectly to promote the interest of this corporation or to enhance the value of its properties; and, in general, to do any and all things and exercise any and all powers, rights and privileges granted by the Laws of the State of Florida to non-profit corporations organized thereunder, and all the powers conferred by all acts heretofore or hereafter amendatory of or supplemental to said law, which are

consistent with the specific purposes for which the corporation is organized.

(8) To enable the Association to accomplish the specific purposes for which it is formed, the Association shall, in addition to the foregoing powers and any and all powers granted by law, have the following powers:

(1) To exercise all the powers and privileges and perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions, hereafter called the "Declaration," applicable to THE VILLAGE AT SCOTT LAKE and to be recorded in the public records of Polk County, Florida, as the same may be amended from time to time as therein provided.

(2) To fix, levy, collect and enforce payment by any lawful means, all charges and assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against property of the Association.

(3) To acquire by gift, purchase or otherwise, own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real property or personal property in connection with the affairs of the Association.

(4) To borrow money, and with the assent of two-thirds (2/3) of each class of members, mortgage, pledge, deed of trust or hypothecate any or all of its real property or personal property as security for money borrowed or debts incurred.

(5) To dedicate, sell or transfer all or any part of the common area to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication or transfer shall be effective unless an instrument has been signed by two-thirds (2/3) of each class of members, agreeing to such dedication, sale or transfer.

ARTICLE III.

This corporation shall have perpetual existence.

ARTICLE IV.

The corporation shall have members which may be divided into such classes as shall be provided in the Declaration of Covenants, Conditions and Restrictions for THE VILLAGE AT SCOTT LAKE. All members shall be accepted, appointed, elected or designated in the manner provided in said Declaration of

Covenants, Conditions and Restrictions. All homeowners must be members.

ARTICLE V.

No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the Association. The Association may be dissolved with the assent thereof discharged or adequate provision made therefore, be dedicated to an appropriate public agency to be used for purposes similar to those set forth in Article II above.

ARTICLE VI.

The affairs of the corporation shall be managed by a Board of Directors of not less than three nor more than seven persons. The Board of Directors shall be elected by the members in the manner provided in the bylaws.

ARTICLE VII.

ARTICLE VIII.

The by-laws of this corporation may be altered, amended, or rescinded at any duly called meeting of the members, provided that the notice of meeting contains a full statement of the proposed amendment, a quorum is in attendance, and there be

an affirmative vote of seventy-five (75%) percent of the qualified voting members of the corporation.

ARTICLE IX.

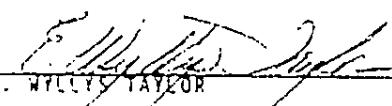
Section 1. Proposals for the alteration, amendment, or rescission of these Articles of Incorporation may be made by any of the voting members. Such proposals shall set forth the proposed alteration, amendment, or rescission, shall be in each voting member notice setting out the proposed alteration, amendment, or rescission and the time of the meeting at which such proposal will be voted upon, and such notice shall be given not less than fifteen (15) days prior to the date set for such meeting, and it shall be given in a manner provided in the by-laws. An affirmative vote of eighty percent (80%) of the qualified voting members of the corporation is required for the requested alteration, amendment, or rescission.

Section 2. Any voting member may waive any or all of the requirements of this Article as to notice by the Secretary or proposals to the President for alteration, amendment, or rescission of these Articles, either before, at, or after a membership meeting at which a vote is taken to amend, alter or rescind these Articles in whole or in part.

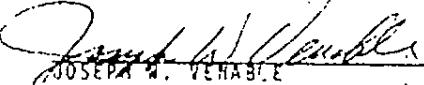
