"ARTICLE I

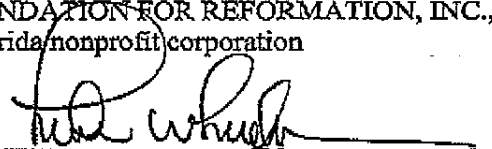
The name of this Corporation is Excelsis Center, Inc."
