Dear Madam Secretary:

As President of a small Homeowner Association in Seminole County, Fl. I recently noticed in checking the State Corp. Web site that our Corp. was dissolved in 1996 due to nonpayment of yearly fees.

In 1994-1995, apparently our then secretary, Joidi Floyd was filing for divorce and changed the mailing address of record to a PO box in Casselberry, Fl. (see enclosures) Apparently she then closed out the box without receiving the annual notice. I have attached an Affidavit from Ms. Floyd to that affect.

At that time there were 12 homeowner members and a new President and Sec. were elected in Dec. 1995.

I was elected in 1999. I would like to ask for your help.

Is there any way you can waive the accumulated fees which now amount to approx. \$480. This amount would place a tremendous financial burden on our small operating budget. We are now at 22 members (maximum only 22 lots in our community) and we sincerely want to be reinstated and pay our future obligations.

I can honestly state that we have no record of receiving the Annual Report notice or any notice of intent to dissolve our Corp.


Would you please consider waiving the fees?
