ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION - FLORIDA CITRUS SPORTS FOUNDATION

To: Department of State State of Florida Tallahassee, FL 32301

Pursuant to the provisions of Section 617, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

SCINGE 3 CO

- 1. Name. The name of the corporation is FLORIDA CITRUS SPORTS FOUNDATION, INC.
- 2. <u>Articles So Modified</u>. The following amendments to the articles of incorporation were adopted by the unanimous vote of the directors of the corporation on January 31, 1997 in the manner prescribed by the Florida Not For Profit Corporation Act:

ARTICLE IV

The membership of this not-for-profit corporation shall be limited to all former Chairmen of the Board of Directors of the Florida Citrus Sports Association, Inc. and any former Presidents of its predecessor corporation, the Tangerine Sports Association, Inc., and the duly-elected current members of the Executive Committees of Florida Citrus Sports Association, Inc. and Florida Citrus Sports Events, Inc. Any other provisions for qualification or admission of members shall be provided for in the Bylaws of the corporation. All members of this not-for-profit corporation shall be active members of the Florida Citrus Sports Association, Inc. or Florida Citrus Sports Events, Inc.

ARTICLE VII

The affairs of the corporation shall be initially managed by the entire Board of Directors until the first annual meeting of the Board of Directors, after which time the affairs of the corporation shall be managed by a Board of Directors elected annually at the annual meeting of the members. The Board of Directors shall be made up of the Chairman of the Board, President, Vice-President, Secretary, Treasurer, and two directors of the Florida Citrus Sports Foundation, Inc., all of whom are former Chairmen of the Board of Florida Citrus Sports Association, Inc. or President of its predecessor corporation, Tangerine Sports Association, Inc. and the duly elected members of the Executive Committees of Florida Citrus Sports Association, Inc. and Florida Citrus Sports Events, Inc. At no time shall the Board of Directors be comprised of less than 60% members of board

members of Florida Citrus Sports Association, Inc. and Florida Citrus Sports Events, Inc.

3. Adoption. This corporation has 17 directors who manage the affairs of the corporation. At the annual meeting called to conduct general business and for the purpose of adopting the foregoing amendments to the articles of incorporation, and certain by-law changes, 11 directors attended the meeting in person or by proxy and voted unanimously in favor of the amendments. This constituted a sufficient number of votes cast for approval of the amendments. There are no members of the corporation entitled to vote on amendments other than the directors.
