**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

The undersigned, a Florida non-profit corporation (the "corporation"), pursuant to the authority of Chapter 617, Florida Statutes, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I. Name

Article II. Amendment

Article I of the Articles of Incorporation is hereby amended to read in its entirety as follows:
