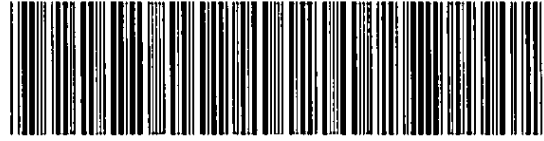

ARTICLES OF INCORPORATION OF
IBIS LAKES HOMEOWNERS ASSOCIATION, INC.
(Document Number N39277)**

1. Article VIII, Section A of the Articles of Incorporation (Board of Directors) shall be amended to read in its entirety as follows:

(new language is underlined; deleted language is struck through)

A. Numbers and Qualifications. The affairs of this Association shall be managed by a board of not less than three (3) nor more than nine (9) directors (the "Board of Directors"), who need not be Members of the Association. ~~The first Board of Directors shall be comprised of three (3) persons. The number of Directors within the limits of not less than three (3) nor more than seven (7), may be changed by amendment of the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of Directors until the selection or election of their successors are:~~

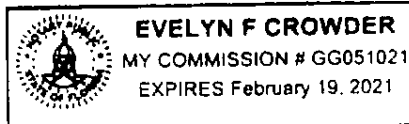




