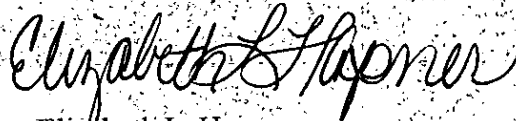
Dear Administrative Agent:
