We the undersigned , hereby associate ourselves to amend the articles of Corporation of T.QUACKENBOS CRUSADES INC. a corporation already established under the laws of the State Of Florida since April 3, 1991, providing for the formation, liability, rights, privileges, and immunities of a corporation not for profit.

ARTICLE 1

The name of the corporation shall continue to be T.QUACKENBOS CRUSADES INC. and shall establish a Church as " CHRISTIAN OUTREACH CENTER" it's business and worship services shall be conducted primarily in the State of Florida particularly in Saint Lucie County.

ARTICLE 2

The reason and purpose of the corporation is exclusively religious, charitable, and educational all within the meaning of section 501 © (3) and 170©(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

To administer the word of God " the BIBLE" through all means possible without bringing embarrassment to the name and purpose of "JESUS CHRIST", to preach the Bible to any and all who would seek the truth from the Bible.

ARTICLE 3

All persons who meet the requirements of the standards of membership as set forth in the BYLAWS of this local Church are eligible for membership

ARTICLE 4

In the event of dissolution, all residual assets of the organization will be turned over to another Church corporation , which themselves are organized as a not for profit corporation under section 501© (3) and 170©(2) of the Internal Revenue Code of 1954 or corresponding sections of Internal Revenue Laws.

ARTICLE 5

The designated agent being: Reverend Timothy Quackenbos Sr., 345 W. Weatherbee Rd. #150, Ft. Pierce, Fl. 34982 the corporation address is 3720 Okeechobee Rd. Ft. Pierce Florida 34947

ARTICLE 6

The affairs of the corporation shall be managed by the President, Elders, Secretary, Treasurer, which shall be not less than three, but as many as the members feel necessary to handle the business of the Corporation, which shall be elected by the members of the corporation in accordance with the BYLAWS of T. QUACKENBOS CRUSADES INC.

ARTICLE 7

The BYLAWS or constitution of this corporation may be amended by a (2/3) vote of the membership at a special meeting called for that purpose; provided that the notice of proposed change shall have been announced at least two Sundays prior to the amendments

ARTICLE 8

No members of the corporation shall have the right to obligate the corporation to any indebtedness without the approval of the officers of the corporation.

ARTICLE 9

This corporation shall have the power to own, use and possess both real and personal property. To contract, to borrow money, to incur indebtedness, to issue bonds, promissory notes, bills of exchange and other obligations of indebtedness, whether secured or unsecured by mortgage, pledge, or otherwise, and shall have all other powers and privileges of a not for profit corporation existing under the Laws of the State Of Florida. The corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under s501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE 10

The corporation shall have an annual meeting to conduct the business and election of officers during the first week of April or as soon thereafter as can be arranged by the board.

These amended articles of corporation were adopted by the directors and officers/^{members} on the 3rd day of May 1999 in witness whereof, the subscribers set their hand and seals this 3rd day of May, 1999
